

**Global perspective on IP and technology / 4th TRADE annual conference,
the impact of tech on retail, Porto, Portugal | 07 October - 09 October 2021**

Requirements to enter Portugal:

- All travellers need to fill a **Passenger Locator Card** (individually) before departure to Portugal or on board at: <https://portugalcleanandsafe.pt/en/passenger-locator-card>
- It is mandatory to present **EU COVID Digital Certificate, or a negative test or a covid recovery certificate**
- The **types of tests** allowed are:
 - 1- RT-PCR carried out within 72 hours prior to submission;
 - 2- Antigen test with laboratory report, carried out within 48 hours prior to its submission
- If you are a **non-EU individual** and want to do the test for Covid-19 shortly after arrival, before departure or at any time in mainland Portugal you can do it:
 - at the Airport. Information at <https://www.ana.pt/en/corporate/ana/faq>;
 - in a laboratory approved by the Portuguese Health General Directorate. Find the list at <https://covid19.min-saude.pt/infoadrpcc/>;
 - in one of the hospitals and clinics included in the Portugal Health Passport that can provide you personalized support in your language. The test for Covid- 19 must be scheduled with a consultation and the results will be available in up to 72 hours.

Valid certificate:

Certificate of vaccination, which is valid in accordance with the following conditions:

- Start of validity:
 - for two-dose vaccination (Comirnaty®, COVID-19 Vaccine Moderna, AstraZeneca, Sinopharm BIBP, Sinovac, Covishield™): on the day of administration of the second dose;
 - for single-dose vaccination (Janssen): on the 22nd day after administration of the dose.
- Individuals with prior confirmed Sars-CoV-2 infection:
 - on the day of administration of the single dose of a two-dose vaccination (Comirnaty®, COVID-19 Vaccine Moderna, AstraZeneca, Sinopharm BIBP, Sinovac, Covishield™)
 - on the 22nd day after administration of a single-dose vaccination (Janssen).
- Duration of validity: 365 days from the date of administration of the last dose.
- Persons who have been vaccinated are persons who have received a vaccine that: is authorised in Portugal and which has been administered by the Portuguese government;

has been authorised by the European Medicines Agency for the European Union and has been administered in full in accordance with the requirements or recommendations of the country in which the vaccination was administered; or

is authorised under the WHO Emergency Use Listing and has been administered in full in accordance with the requirements or recommendations of the country in which the vaccination was administered.

- Certificate of recovery from COVID-19 from the 11th day after the positive test result and lasts for 180 days from the date of the test result.
- A pre-departure PCR test (taken within 72 hours prior to arrival) or a rapid antigen test (taken within 48 hours prior to arrival). Note: Each RT-PCR test may cost around 70€

Requirements to enter the AIJA event:

- Participants should be carrying a valid Covid certificate **with a valid QR code** which will be or scanned at the hotel/AIJA venue using [the Portuguese App](#). A valid QR code can be:
 - Vaccination certificate with a QR code
 - Valid PCR test with a QR code
 - Valid antigen test with a QR code
- Participants must carry their ID card or Passport
- The Portuguese authorities made it compulsory to wear a mask in all indoor venues. Therefore, it will be enforced at the seminar.
- To social distance is compulsory in Portugal and participants will have to respect it throughout the AIJA event

AIJA reserves the right to decline the entrance to participants who do not comply to the above.

When registering for the AIJA event, participants agree to the below terms and conditions:

- Should you develop any COVID symptoms develop
 - pre-event: you will not attend the AIJA event
 - during-event: you will inform the AIJA staff by email (office@aija.org) and self-isolate
- AIJA cannot be held responsible if you contract COVID pre/during/after the AIJA event.
