A corporate investigation may begin if fraud is suspected within an organisation or as a consequence of the initiation of a domestic government or international regulatory investigation. This is a difficult area and it is crucial that the lawyers, at the centre of the maelstrom, ensure they can give the right advice.

The Commercial Fraud, Litigation, Labour Law and Corporate Counsel Commissions will organize a top-flight seminar that will guide delegates through the myriad of challenging issues facing lawyers dealing with an internal corporate investigation.
